According to [4], Web Scraping automates this process and helps you display all the data at the same place with ease and in a small amount of time. Main objective of Web Scraping is to extract information from one or many websites and process it into simple structures such as spreadsheets, database or CSV file. In our website, we have made use of this technology to solve a important social issue. Many cases of abuse have been increased with the use of Internet. Our website allows the authorized communities to search for such abuse related posts from different websites, while staying on a single webpage. The user will just have to enter the keyword, for e.g. — women abuse, and he will get the posts from several number of websites on a single webpage. The method explained in this paper is applied to a popular social platform — 'Twitter' as a use case. It can be applied to a number of websites. This will help the authorities to save time in searching for such crimes and give more time to solve these issues.

As the Internet sets out to connect the world, more people than ever are using the Internet and the World Wide Web in their everyday lives. According to [1], estimates have found that in 2000, there were around 400 million users of the Internet, while in 2015, there were around 3.2 billion users, an increase of 2.8 billion in 15 years (ITU, 2015) along with the proportions of the populations of developed, developing and least developed countries (LDCs) who have access to the Internet. As the Internet and the World Wide Web continue to grow and amass more users, there is a higher risk of criminal activity. Currently, the web is uncontrolled and unregulated, which allows anyone to utilise it for communication and create their own websites with documents, links and their own content (Albert et al., 1999). The core child protection legislation for children is enshrined in four main laws: The Juvenile Justice (Care and Protection) Act (2000, amended in 2015); The Prohibition of Child Marriage Act (2006); The Protection of Children from Sexual Offences Act (2012), and The Child Labour (Prohibition and Regulation) Act (1986, amended in 2016). Also, for women abuse, several steps are taken by the government. Some of them are:- Expansion of helplines and information sharing, Funding shelters and other safe accommodation options for survivors, Expansion of access to services for survivors, Limiting risk factors associated with violence, Modifications to family law and justice systems Information is being shared widely through guides, resources, and advocacy targeting friends and family members. Parenting for Lifelong Health has compiled evidence-supported guidance for safe parenting during quarantine. Helplines online support platforms are being expanded or established. Italy, one of the countries hardest hit by the pandemic, is preventing "an emergency within an emergency" by advertising the 1522 helpline for violence and stalking.

Over the past five years, notable efforts have been made to set up fast track courts and deal with cybercrime against children and women. In 2019, the Protection of Children from Sexual Offences Bill was amended, stipulating stricter punishment for sexual crimes against children. Exact data on violence, abuse and exploitation is not sufficient, but overall, the nation is becoming increasingly aware of violence against children, especially sexual abuse. V. IMPLIMENTATION

In our project we take the input from the user in the form of hashtags/keywords which will be used for the data extraction from twitter with the help of selenium using python. This whole project is developed with the help of Django framework where Selenium is a free (open-source) automated testing framework used to validate web applications across different browsers and platforms. The Selenium API uses the WebDriver protocol to control a web browser, like Chrome, Firefox or Safari. The browser can run either locally or remotely. To scrape data from these browsers, selenium provides a module called WebDriver, which is useful to perform various tasks like automated testing, getting cookies, getting screenshots, and many more. In order to extract the information that you're looking to scrape, you need to locate the element's XPath. An XPath is a syntax used for finding any element on a webpage. Once the information is located that we have searched int the form of hashtags/keywords, it will iterate through number of paths that contains the required hashtags and collects all the require data and displays it on our web page.

VI. EXPERIMENTAL RESULT

The solution proposed in this paper was implemented on one of the most popular social media platforms - Twitter and the results were positive i.e. we are successfully extracting the following user information like user's twitter id, user's twitter name, time of tweet and his/her tweet. We were able to extract this useful information about the abuse related posts. Till now, web crawling was used to address various crime related activities in different domains. Our paper differs in terms of method and the social issue that was resolved through this case study as we are using selenium for extracting data from the twitter.
